Costa Procurement team has started sustainable packaging journey since 2013. In 2022, the business continued to move more into PET, so majority of punnets are RPET. Next step involves moving to locally sourced PET (i.e. in Australia) to the extent that it is available.

Conducted RPC trial to investigate feasibility of reusable packaging as an alternative to cardboard packaging.

Costa's aim is to ensure that we buy the most recyclable materials possible.

Costa has externally released its 2022 Sustainability Report which goes through how the business is reducing the use of non-recycling packaging (page 19). Maintaining shelf life and produce quality in the most sustainable, environmentally friendly way which includes reducing Costa's packaging footprint is one of key sustainability goals.

# **Design & Procurement:**

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Review 100% of our packaging against the Sustainable Packaging Guidelines (or equivalent).
- Improve the accuracy of our data regarding reviews of packaging using the Sustainable Packaging Guidelines (or equivalent).
- Incorporate the Sustainable Packaging Guidelines (or equivalent) into procurement processes.
- Consider the following Sustainable Packaging Principles in our packaging reviews:
  - Design for recovery
  - Optimise material efficiency 0
  - Design to reduce product waste
  - Eliminate hazardous materials 0
  - Use of renewable materials o
  - Use recycled materials 0
  - Design to minimise litter 0
  - Design for transport efficiency 0
  - Design for accessibility 0
  - Provide consumer information on environmental sustainability
- 100% of our packaging to be optimised for material efficiency.
- Improve the accuracy of our data regarding packaging material efficiency.

#### Criteria 3:

### **Recycled Content:**

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Use recycled content in:
  - Primary packaging that we use to sell our products
  - Secondary packaging that we use to sell our products
- 94% of our packaging to be made using some level of recycled material
- Improve the accuracy of our data regarding use of recycled materials.

#### Criteria 4

## Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- 99% of our packaging to be designed to have all packaging components be recoverable at end-of-life.
- Improve the accuracy of our data regarding recoverability.
- Use PREP to assess the recyclability of our packaging through kerbside collection in Australia and/or

New Zealand.

- Aim to have 100% of our compostable packaging certified to Australian standards.
- Investigate opportunities to use reusable packaging.
- 5% of our packaging to have all packaging components that are reusable.
- Improve the accuracy of our data regarding reuse.
- Participate in a close-loop recovery program/alternative collection system.

#### Criteria 5:

#### Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

- 50% of our packaging to have on-pack labelling to inform correct disposal.
- Improve the accuracy of our data regarding labelling.

#### Criteria 6:

#### **On-site Waste:**

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Have recycling programs for the following materials:
  - Paper/cardboard
- Aim for 84% of our on-site waste to be diverted from landfill.
- Improve the accuracy of our data regarding on-site waste.

#### Criteria 7:

### **Problematic Materials:**

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Help reduce litter by:
  - Conducting regular clean ups
  - Clean up Australia Day at a local level at several of Costa's farms.
